# REQUEST FOR BIDS CITY OF DUNN HIGHWAY 301 SOUTH ELEVATED TANK DMP PROJECT 240047

Sealed proposals will be received by the Dunn City Council, Harnett County, North Carolina until <a href="Thursday">Thursday</a>, <a href="January 9th">January 9th</a> at 2:00 pm and then will be publicly read aloud for the construction of "City of Dunn, Highway 301 South Elevated Tank".

The construction work will consist of the following major quantities:

- 500,000 gallon elevated steel storage tank either multi-columned or spheroid styles

Proposals must be sealed and marked "City of Dunn, Highway 301 South Elevated Tank" on the outside of the envelope. All proposals must be submitted upon the blank forms provided in the copies of the Proposal, Contract and Specifications.

No bid may be withdrawn after the scheduled closing time for receipt of Bids for a period of ninety (90) days. Any Bids received after the scheduled closing time for receipt of Bids will be returned to the Bidder unopened. The City reserves the right to retain Bids for a period of 90 days from receipt.

Each bid must be accompanied by Bid security in an amount of not less than five percent of the amount of the Bid. Security may be in the form of cash, a certified check made payable to the City of Dunn, North Carolina and drawn on a bank or trust company insured under the Federal Deposit Insurance Corporation, or a Bidder's Bond.

All payments are to be made to Duncan Parnell, via their bid room. <a href="https://bidroom.guncan-parnell.com/">Prospective prime bidders must purchase Bidding Documents directly through Duncan Parnell to be considered a bonafide bidder.</a>. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda, obtained from any other source. Small, minority, and women's businesses and labor surplus area firms are encouraged to submit bids.

Both Performance Bond and a Payment Bond is required in an amount equal to 100 percent of the Contract price, conditioned upon the faithful performance of the Contract and upon the payment in full to all persons supplying labor and furnishing materials for and in connection with the construction of the project.
